We acknowledge receipt of your letter dated October 20, 2023 regarding The Park National Bank's plans to close its branch office located at 5100 St. RT. 132, Owensville, Ohio 45160, known as the Owensville branch on January 22, 2024. The bank's decision to close the branch office is a business decision that does not require the approval of the OCC. However, we will consider your comments in connection with our next Community Reinvestment Act (CRA) evaluation of the bank when we will review the effect of the bank's record of opening and closing offices. In addition, we will take the bank's record of performance under the CRA into account when we review applications by the bank to establish or relocate branches or to merge with other banks.

We have sent a copy of your letter to Michael Fee, Compliance Staff at The Park National Bank, 21 S. 1st Street, Newark, Ohio 43055. Please pursue further inquiries directly with Mr. Michael Fee. Please indicate the name and address of the branch in all correspondence.

We have forwarded your comment letter to the OCC's Community Affairs Department in Washington, D.C. Community Affairs will advise you if we intend to convene a meeting with community representatives to explore the feasibility of obtaining alternative financial service facilities. 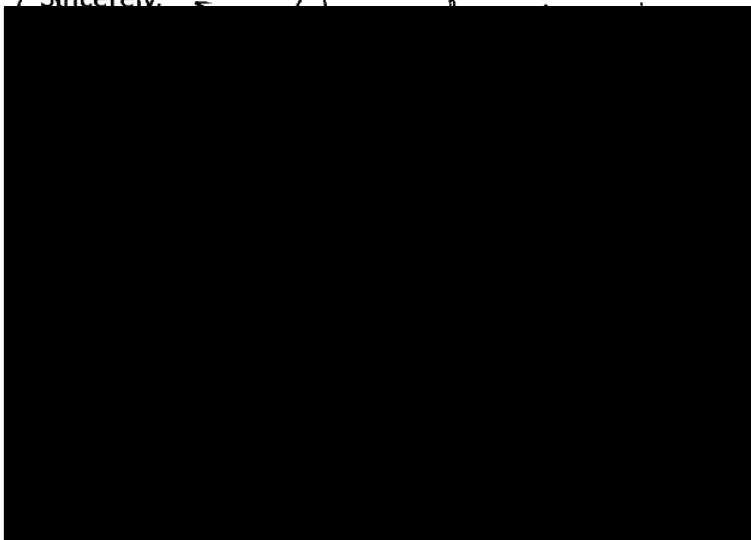
